New York City Health Code requires that the permit issued by the Department of Health and Mental Hygiene must be kept on the premises designated on the permit and it must be placed in a clean, transparent cover or frame and displayed in such a manner as to be clearly visible to the public.

Cannabidiol (CBD) is Prohibited in Food and Drink: In December 2018, the Food and Drug Administration (FDA) issued a statement clarifying its position on cannabis-derived products. The FDA stated that it is unlawful to add CBD to food or drink. As a result, the Health Code also prohibits adding CBD to food or drink. Food or beverage products that contain CBD are considered adulterated and are subject to enforcement actions which currently, include voluntary removal and discarding of products, returning products to the supplier, embargoing and/or destruction of products. Starting October 1, 2019, the Health Department will begin issuing violations to food service establishments for offering food or drink containing CBD.
